

## Terms & Conditions

### PROMOTION 1: FIND YOUR FAST CHALLENGE

By entering this competition (the "Promotion"), you (the "participant") agree to be bound by these

terms and conditions. Any information or instructions published by the Promoter (as defined below)

about the Promotion (including on the Promoter's websites) form part of these terms and conditions.

#### Definitions

Consenting Adult – person over the age of 18 who has authority to provide consent for an under 18

to take part in the Promotion.

Product – Catapult One vest and GPS tracking device (pod)

Promoter – Catapult Sports Pty Ltd ABN 66 137 513 378 of 75 High Street, Prahran, VIC 3181,

Australia

#### Eligibility:

1. The Promotion is open to all participants registered for the Gothia Cup aged over 10 years old or over, excluding employees of the Promoter, its agents and anyone professionally associated with the Promotion.

2. All participants under the age of 18 must have permission from a Consenting Adult.

3. No purchase necessary; however, a credit card is required for security purposes and will only

be charged if the Product is not returned within 24 hours.

#### Entry:

4. To enter the Find Your Fastest Promotion visit the Catapult One exhibition stand located at

the Gothia Cup between Sunday 17 th July and Saturday 23rd July 2022 and loan the Catapult

One tracking device which will track your highest speed while you play football.

5. At the Catapult One exhibition stand entrants are be entitled to loan the Catapult One Product and wear it to play football during the tournament for a maximum of 3 hours.

6. To loan the Product you will be required to complete a form to provide your first name initial

& surname or an 'alias' and gender, for the purposes of conducting the Promotion.

7. If you are under the age of 18 years old a Consenting Adult will need to approve your participation in this Promotion including the Product loan and final by supplying their details (name, address, postcode, email address, mobile phone, number date of birth and team name) and provide a signature.

8. For security purposes the person loaning the Product (if over 18) or Consenting Adult (if the

participant is under 18) will need to provide details of a credit card. If the Product is not returned within 24 hours the credit card will be charged for €266 for purchase of the Product.

9. The person loaning the Product will be provided with a time slot in which you can loan the

Product. On expiration of your time slot you must return the Product to the stand where you loaned it from.

10. The GPS data from the Catapult One tracking device will be downloaded to a laptop device

and you will be informed of your fastest speed. Your fastest speed will be added to the leader board in public view on the stand if you are in the top 50 males or females.

11. All GPS data captured on all Catapult One devices will be deleted once downloaded to a laptop.

12. All GPS data downloaded to a laptop for the purposes of display will be deleted after 23rd

July 2022.

13. For the avoidance of doubt eligible participants may loan the Catapult One Product from Sunday 17th July until Saturday 23rd July.

14. The Promoters reserve the right to exclude participants from this Promotion at their discretion.

Privacy and Data Protection

15. The Promoter and its agents will need to process personal data about participants in order

to run the Promotion. All personal data about participants will be handled in accordance with the Promoter's privacy policy available at <https://images.catapultsports.com/wp-content/uploads/2021/09/16074615/Catapult-Standard-Privacy-Policy-Final-16-September-2021.pdf>

16. Except as described below, all personal data supplied for this Promotion will be used solely

for the purpose of this Promotion by the Promoter and/or by any agent appointed by it to assist with running the Promotion and will not be disclosed to an unconnected third party unless your positive consent has been obtained.

17. The Promoter may wish to use any personal information submitted on the entry form or otherwise in the course of the Promotion to advise participants of future promotions and to provide information about products of the Promoter or its associated companies that may be of interest. The participant (or the Consenting Adult in the case of under 18s) will be asked to give their consent to such personal information being used for this purpose.

Consent to such use of personal information can be withdrawn at any time by writing to the Promoter or by using the opt-out process outlined in the Promoter's privacy policy.

18. All data for participants under the age of 18 will be destroyed by Monday 25th July 2022.

19. The Promoter may request that participants may participate in publicity arising from the Promotion including featuring in content. Participation is at the discretion of the individual but unless participants notify the Promoter that they do not wish to feature in any promotional content each participant (or the Consenting Adult on behalf of the participant in the case of under 18s) hereby provides a non-exclusive, royalty-free, irrevocable, perpetual, transferable licence to the Promoter to use content relating to the Promotion featuring the participant for any purpose, including without limitation for advertising the Promoter's products. The participant (or the Consenting Adult on behalf of the participant in the case of under 18s) hereby waives all moral rights they may have in respect of content

relating to the Final which may feature them, to the fullest extent permitted by law.

General Terms and Conditions

20. The Promoter seeks to run a fair and secure promotion and prevent abuse and cheating.

If

you enter or take part in a way that is not consistent with these Terms & Conditions, your

entries (and any of your associated aliases) will be disqualified.

The Promoter reserves the right at any point to:

- o Verify the eligibility of participants and/or provisional winners by requesting such information it considers to be reasonably necessary for this purpose.

- o Disqualify participants who tamper with the entry process or otherwise interfere with the fair running of the Promotion.

- o Disqualify participants who do not participate in the Promotion in a fair manner, or who behave in any way which, at the Promoter's sole discretion, may be deemed to be offensive, sexually explicit, rude, disparaging or otherwise inappropriate.

22. You acknowledge and agree that despite the Product having been designed to minimize the

risk of personal injury to users of the Product, there is a remaining inherent risk of injury.

You are responsible for all risks arising out of or in connection with the possession, operation

and use of the Product, both during the Promotion and afterwards.

23. The Promoter will not be liable for any delay or failure to comply with its obligations for reasons beyond its reasonable control arising from but not limited to Acts of God, global or regional epidemic or pandemic, adverse weather conditions, fire, industrial dispute, war, terrorist activity, hostilities, political unrest, riots, civil commotion, plague or other natural calamities, or any other circumstances.

24. If any part/s of these Terms & Conditions are legally ruled to be invalid, illegal or unenforceable, the remainder will not be affected and will continue in full force and effect.

25. If there is a discrepancy between these Terms & Conditions and those in any promotional

material, these Terms & Conditions will prevail.

26. These Terms & Conditions are governed by Swedish law and their interpretation and application will be subject to the exclusive jurisdiction of the courts of Sweden.
